### BMV DEALER FLEET MAILING – TITLE SERVICE

The Indiana Bureau of Motor Vehicles has notified ADAI that a letter was sent yesterday to every dealer registered with their Dealer Fleet branches regarding their title service. The text of the letter follows:

*“Over the past few years, the BMV has implemented several different processes for dealer title service in an attempt to find a system that was efficient, timely and cost effective for both the dealer and the agency. Our goal of assisting the individual customer with overall branch visit times of less than 15 minutes must also include how we can enhance the commerce aspect of our corporate customers such as you.*

*With this philosophy in mind, we will be adopting the following rules for dealer title processing in branches, effective October 1, 2012:*

- *All titles brought to the branch will be processed within three (3) business days.*
  - *Knowing the three day turnaround time will allow our dealer customers to plan appropriately.*
  - *Titles with corresponding registrations will be processed while you wait.*
- *If the branch has available resources at the time the title(s) is/are dropped off, branch management has the authority to process as many dealer titles as resources permit while you are in the branch. Please note, this may result in some titles being processed immediately, while others will be subject to the three day turnaround time.*
- *“Premium” services providing enhanced/immediate title processing services tailored for dealers are available through our BMV Certified Partners, located throughout the state. These partners are listed on the myBMV.com website.*

*We are confident that this new process and options available to you will provide more flexibility, consistency and dependability in meeting your titling needs. Thank you for your cooperation in this matter.”*
