SUBJECT: **Dealer 'M' Plate – 2008 RENEWALS**

## Background & Update

Last October, the ADAI contacted all known new-car and new heavy-duty truck dealers regarding a pre-order of their metal "M" dealer license plates for 2008. The initial ADAI pre-order for dealer "M" plates was forwarded to the Secretary of State (SOS) Dealer Services. After reviewing the information submitted by ADAI, the SOS made revisions and placed the plate order.

## 2008 License & Plate Renewals

*ADAI will not be processing 2008 dealer plate renewal. The Dealer Services Department of the Secretary of State processes dealer license and plate renewal applications. Dealers are reminded that 2008 is the beginning of the new five-year plate cycle. You will receive new metal license plates instead of stickers. The SOS hopes to have all pre-ordered dealer "M" plates on-hand for delivery upon processing of the dealer's 2008 business license renewal application.*

The SOS will be sending out 2008 Motor Vehicle Business License Renewal Applications approximately one month prior to the expiration date of the 2007 license/plates. Please review the application information carefully ... license number, business name & address, number of plates. Make changes as needed and complete the requested information. Prior to returning the completed application and required fee, **dealers are asked to conspicuously indicate their "M" dealer plate number on their 2008 renewal application.** This can be done by simply writing on the form or attaching a note stating:

*"This dealership has a pre-ordered "M" series plate number \_\_\_\_M."*

This will alert the application processing clerks to pull the appropriate new-car dealer "M" plates instead of the new consecutive dealer "A" plates.

***REMEMBER – you will not receive your 2008 dealer plates from ADAI.*** If you have any problems getting your 2008 dealer "M" plates, do not hesitate to contact ADAI at 800.872.0363. We will contact SOS Dealer Services and work to remedy the problem.
